<b>Finances: Joe</b>  <b>Membership</b>	<p>See attachments for the present status and the reconciliation of the budget.</p> <p>We will continue to pay for the <b>storage spaces at Sir Richard's</b> and then be reimbursed by the town. No change.</p> <p>There are <b>36 expired memberships</b>. 19 of those receive a paper newsletter. The consensus was to use <b>postcards</b> of Waterbury from Luce's store to send a dues reminder to those 19. Several board members will write the postcards.</p> <p>The cards can also be used as thank you notes. <b>Ghost Walk: Jan Monday, May 27</b>	The ghost walk will be at the Maple Street Cemetery in Waterbury Ctr. Brian Lindner will be the Master of Ceremonies.	<i>Jan and the American Legion</i>
<b>Collections -Acquisition</b>	Cheryl will call Merrill's Auction Barn when the items are all gathered in one place. The items will be those that have been decessed or were never accessed.	<i>Jan, Jill, Anne, Margaret and Cheryl</i>
<b>Collections Manager Position</b>	The advertisement for the collections manager position is all set to be posted. It will be posted on various media sites.	<i>Anne, Jill, and Cheryl are on the search committee.</i>
<b>Strategic Planning</b>	<b>The strategic plan will be presented in the fall which will include a mission statement, a visions statement, and a values statement.</b> The following is a proposed <b>mission statement</b> : "To be the go-to educational resource with convenient access to our archives, programs, and the History Center engaging community members of all ages, researchers, and tourists interested in Waterbury's history and its relevance to the broader story of Vermont." Joe made a motion to accept the statement, Anne 2 <sup>nd</sup> . Approved. A <b>visions statement</b> and a <b>values statement</b> need to be drafted. A <b>visions statement</b> is critical for our story telling. It needs to include benchmarks for action plans, a structure for our narrative, it will help in grant writing and will tell what our organization is about and what it strives to be. A <b>values statement</b> will tell how we conduct our business. It will speak to Connection, Community, Preservation, Integrity, and Sustainability.	<i>Cheryl will bring handouts next meeting so we can finalize the <b>strategic plan</b>. She will also resend on Google Docs. What is doable in the next five years? <b>Focus?</b> <b>Past Perfect?</b></i>
<b>New Business</b>	A volunteer is needed as a <b>coordinator for Past Perfect</b> . Need someone to <b>recruit and train volunteers</b> . <b>Nominating committee</b> needs redefining. Bill Woodruff is the Chair, two other folks are needed.	<i>Cheryl</i>  <i>Bill</i>
<b>Jack's Alley</b>	An alley off Stowe Street is being prepared to honor Jack Carter, former curator for WHS and former owner of the Stowe Street Emporium. Revitalizing Waterbury, the VT Agency of Commerce and Community Development are raising funds – the goal is \$20,000 by June 14 for a piece of abstract art. Presently they are about halfway to their goal.	<i>Jack was a superb booster of art and all things related to Waterbury.</i>
